Revised Rules/Regulation for Regulating Dharmapada Award and ~~and~~ Ovation to the Deserving Artist/Art personalities of Odisha Lalit Kala Akademi, Bhubaneswar

1. **"Dharmapada" Award**

The highest award of the Odisha Lalit Kala Akademi shall be named as Odisha Lilit Kala Akademi Sammana and shall be called as "Dharmapada Sammana". It shall be decided as follows.:

(a) **Dharmapada Award (Sammana)** shall be conferred on the life time achievements and contributions of an Odia Artist towards the conservation, propagation and development of art and crafts tradition i.e. traditional art, contemporary art, Odishan art etc. of the State of Odisha.

(b) **Eligibility Criteria-** (i) An artist of 60 years and above as on the 1st day of January of the concerned year of award would be eligible for consideration of the award which carries a cash prize of Rs.1,00,000/- (may be revised by Govt. from time to time), a citation and a shawl or as per decision of the Govt.

(ii) Any artist applicant/candidate should be an acclaimed artist with recognition at the State/National level and also a felicitated artist with the ovation awarded by the Odisha Lalit Kala Akademi in previous years.

(iii) Any artist applicant/candidate should ordinarily not be a member of General Council (President/Vice-President/Secretary/Any Member of the Odisha Lilit Kala Akademi)

(c) **Selection Procedure**

(i) Self nomination/proposals/collection of nominations from the deserving artist/art personalities/Cultural organisation/District Council of Culture shall be accepted within a due date as prescribed by OLKA.

(ii) All the nominations/proposals received shall be compiled by the Odisha Lalit Kala Akademi and the same will be placed before the Award Selection Committee consisting of seven (7) members duly constituted by the Govt. for recommendation of maximum of three (3) eminent personalities for Dharmapada Award for a particular year and maximum ten (10) names for ovation for final selection of Dharmapada Award (any one) and for ovation (five) names of art personalities.

(iii) Deserving candidate below the age of 60 can also be recommended by the seven (7) members committee for consideration in exceptional circumstances with sufficient justification.

iv) Suggestions of the Award Selection Committee may also be placed before the General Council of Odisha Lalit Kala Akademi. If there are any serious objection to the recommended list of nominees, then it will be let know to Govt. within three weeks of receipt of the list from the Committee. Otherwise it will be proved that there is no objection.

(v) The final selection for Dharmapada Award (any one out of recommend list) and ovation (any five out of the recommended list) shall be made at Govt. level on the basis of recommendations placed by the seven (7) members Recommendation Committee.

(d) **Constitution of the seven (7) Members committee**

(i) The proposed committee of 7 members shall be constituted with the President, Secretary of Odisha Lalit Kala Akademi and a Dharmapada awardee in previous years (as would be decided by Govt.)

(ii) The rest four (4) members shall be nominated by the Govt. for the purpose as recommended by a Search Committee of the Administrative Department with Govt. approval. The Chairperson of the said seven (7) members of Recommendation Committee will also be appointed by the Govt.

(e) **Dispute/Doubt**

No dispute and doubt shall be entertained in the matter of selection of Awards and decisions of the Akademi shall be final and binding.

(f) **Funds**

Funds for the purpose of expenditure for awards/ovation shall be met by the OLKA from allotted/grants received from Administrative Department.

(g) **Miscellaneous**

The Government may review the matters relating to the number of Awards and cash reward amount from time to time as per the advice of the Akademi. For the time being, the list of awards/honours/Sammanas with the award money approved by the Govt. vide Resolution No.4628 dtd. 22.7.14 shall be adopted as follows:
