Section Officers, Section Officers, Desk Officers, Under Secretaries, Deputy Secretaries, Joint Secretaries and Additional Secretaries for their engagement as "Officer on Special Duty" on contractual basis in Tourism & Culture (Culture) Department against the vacant post of A.S.O. under the following terms and conditions within 15days from the date of publication of the Notice in the local dailies.

- (i) The retired officer must not be above the age of 62 years. He/She must have good service records and he/she is physically fit to discharge the Government duty.
- (ii) The retired officer against whom vigilance case/Departmental Proceedings/Criminal Prosecution is contemplated or pending or who has been penalized for misconduct during the period of ten years preceding his/her retirement will not be considered for re-engagement.
- (iii) The retired officer who has been a member of any political party after his/her retirement shall not be eligible for re-engagement.
- (iv) The appointee has to discharge the duties as prescribed by this Department from time to time.
- (v) Performance of the appointee shall be monitored rigorously by the Department against the monthly targets assigned to him.
- (vi) The Contractual engagement will be made for a period of one year and that may be extended by a further period of one year subject to satisfactory performance and shall not be extended beyond attaining the age of 62 years by the contractual employee.
- (vii) Consolidated remuneration of the contractual employees shall be at the rate of his/her last Pay + Grade Pay drawn minus the amount of pension sanctioned per month subject to a maximum of Rs.10,000/-per month.
- (viii) During the period of the contractual appointment, the appointee shall also be entitled to get travelling allowances for approved tours at the rate he was entitled for at the time of his retirement.
- (ix) The period of contractual engagement shall not be counted as Government services for the purpose of pension or any other retirement benefits.

- (x) The contractual engagement may be terminated at any time by the Department for unsatisfactory performance, on notice of one month and in case of any misconduct including, but not limited to misappropriation, negligence or causing loss to Government without any prior notice.
- (xi) General instructions of Government regarding terms and conditions for contractual engagement as issued from time to time will be applicable and binding on the officers.
- (xii) In case the officer desires to resign from the engagement, he/she may do so by giving a notice of one month in writing to the Commissioner-cum-Secretary to Govt., Tourism & Culture (Culture) Department. After expiry of the notice period, the officer may be relieved after handing over full charges of records to the relieving officer as decided by the Department.
- (xiii) The engaged officers will be subject to and will abide by the Conduct Rules applicable to the Government servants.
