The previous empanelment exercise resulted in a limited number of agencies being enlisted, which did not adequately reflect the diversity and capacity available in the market. The current RFP aims to rectify this by inviting a wider pool of applicants and thereby enhancing the quality and reach of services provided under OLL&CD.</p> <p>All agencies, including those currently empanelled, are therefore mandatorily required to submit fresh applications in accordance with the schedule and guidelines prescribed in the current RFP document.</p> <p>No exceptions shall be made in this regard.</p>
